1. Funding Request for 2026/27:

- Rumpelstiltskin Alberta Musical Theatre Company: CAD 2000.00; - All OK - PASSED
- Three Left Feet: CAD 7,200; - All OK – PASSED. Can consider doing a STEM/art along with a phy ed residency in the coming years/ Residencies limited to those who are already on the CBE roster due to insurance/security clearance issues in the past for some schools.
- Pizza for final school council meeting CAD 200.00 – All OK – PASSED.

2. GICs were renewed: interest was CAD 273.00 from the CAD 13,000 general fund (TLC SCHOOL COUNCIL ACCOUNT THE PARENT SOCIETY OF THE TLC) and CAD 1680.00 from the CAD 80,000 casino fund (PARENT SOCIETY OF THE TRADITIONAL LEARNING CENTER AT COLONEL SANDERS SCHOOL) next year the rate will only be 1.9%. We did 13,00 from general fund and 40,00 from casino fund. This had all been agreed to at the last meeting and GICs are all now in place.

3.
